PROCÈS-VERBAL OF RECTIFICATION

to the Treaty between the Kingdom of Belgium, the Czech Republic, the Kingdom of Denmark, the Federal Republic of Germany, the Republic of Estonia, the Hellenic Republic, the Kingdom of Spain, the French Republic, Ireland, the Italian Republic, the Republic of Cyprus, the Republic of Latvia, the Republic of Lithuania, the Grand Duchy of Luxembourg, the Republic of Hungary, the Republic of Malta, the Kingdom of the Netherlands, the Republic of Austria, the Republic of Poland, the Portuguese Republic, the Republic of Slovenia, the Slovak Republic, the Republic of Finland, the Kingdom of Sweden, the United Kingdom of Great Britain and Northern Ireland (Member States of the European Union)

and

the Republic of Bulgaria and Romania,

concerning the accession of the Republic of Bulgaria and Romania to the European Union,

signed in Luxembourg on 25 April 2005

1. The Protocol concerning the conditions and arrangements for admission of the Republic of Bulgaria and Romania to the European Union is amended as follows:

(a) on page 29, in the title of the Protocol:

(b) in Annex VI to the Protocol (List referred to in Article 20 of the Protocol: transitional measures, Bulgaria), Chapter 10 (Environment):

(i) on page 123, Part B (Waste management), paragraph 3 (temporary derogations to Council Directive 1999/31/EC of 26 April 1999 on the landfill of waste), point 7:
